Visits from One Medicare

Aisha Munir (Head of Employee Experience) and George Moxon (Head of Workforce Planning and Development) are visiting on Weds (tomorrow) and Thursday this week. They have some specific meetings booked in and will be around over breaks for you to say hello or ask any questions. Hayley will let you know where they are if you wish to see them.

It is our understanding that the individual 1-1 staff consultations are to start on w/c 5th June.

There will be regular visits from different One Medicare teams. They are keen to be present regularly to allow the opportunity for questions whilst getting to know CKMP.

Linking in remotely with One Medicare

The Lead Nurse Team are meeting with the One Medicare nursing team very shortly to work out an overall plan in light of the pre-planned changes in this team afoot.

This week the operational lead Laura Law and the GP development lead Lysander joined our PLT last Friday and will be attending on an alternate week basis from now on in order to understand what we do and to give a One Medicare view where needed.

Will Dawson and Kate Parker met with me, Andrea and the PCN leadership team today to be introduced. The One Medicare Team confirmed that they wish to continue membership of the BIC PCN. They seek to continue and build upon the good work that the PCN are doing around health inequalities and staff wellbeing. There is no plan to change anything about our current PCN roles at CKMP.
